- 6. Tucson 'Water's Per- Poly fluoroalkyl substances (PFAS) Management & Tucson Airport Remediation Project (TARP) update – Interim Director John Kmiec provided a brief update; those items reviewed and discussed were:

Tucson 'Water's recent award from Water Alliance as a National Leader for a Public Utility and committees' role. He also appreciated the committee for guiding the utility and the council. The council member shared his perspectives on Water, and his primary focus PFAS – the city's response to the contaminant and litigation status.

#### 8. Differential Water Rates Discussion -

- a) Interim Director John Kmiec shared the June 22 Mayor and Council decision to implement Differential Water Rates. The council was provided eight options for consideration. The council voted to implement option #7, 10% on the base rate plus escalating tiers beginning December 1, 2021. The council also directed staff to provide a Cost of Service (COS) analysis.
- b) Deputy Director Silvia Amparano provides a preliminary calendar of staff processes regarding differential water rates and COS analysis. Additional calendar dates were provided regarding regular financial planning and rate development.
- c) Finance subcommittee Chair Steve Washburn shared an overview of the July subcommittee meeting, which incorporated phase 1 of the COS analysis
- d) Open Discussion chair Taylor allowed members to add to the discussion.
