1. Call to Order and Introductions
A quorum was established. **Stacy Rodenberg called the meeting to order at 5:48 p.m.**
2. Approval of 09/22 Meeting Minutes

3. Mayor and Council Updates
Staff provided an update on Mayor and Council discussions related to Move Tucson and the RTA Next planning process. **No Action Taken.**
4. Review and Approval of Draft Final Move Tucson Plan
The CSCC discussed and took action on the final draft Move Tucson plan. There were two motions made on the Draft Final Move Tucson

Motion 1: Include a 4th funding scenario in the body of the Move Tucson plan on the following rationale:

Robust public transit funding is a critical element in supporting many goals related to our climate action emergency, such as shifting transportation mode choices, more equitable land use, etc.

Public leadership is necessary to advance support for funding for transit operations to increase frequency, weekend & evening service).

An additional piece for consideration are the trade-offs between funding allocations for streetcar, BRT, and other transit service upgrades. If it is clear that funding for streetcar routes are not feasible within the first 10 years of Move Tucson implementation, that funding capacity should be reallocated to Bus Rapid Transit projects or to funding for the long-range recommendations from the Long Range Regional Transit Plan.

Motion 2: Recommend approval to Mayor and Council of the draft Move Tucson plan with inclusion of the 4th scenario reflected in the Implementation Plan.
