1. Call to Order/Roll Call

2. Low-Income Rainwater Harvesting Evaluation – (Item was taken out of order) Lucero Radonic, Sonoran Environmental Research Institute (SERI) presented a report on her findings. Those items reviewed and discussed were:

a. Objectives

- b. Summary of Top-Level Findings
 - i. Most of the participants had engaged in a rudimentary form of rainwater harvesting before participating in the Low-Income Rainwater Harvesting Program
 - ii. For a majority of participants (65.6 %), financial assistance through the Low-Income Rainwater Harvesting Program was the deciding factor for adoption.
 - iii. Customers were socio-economically diverse
- c. Rainwater Harvesting
 - i. Participants made a distinction for themselves regarding their changing relationship with this technology.
- d. Past Experiences with Rainwater Collection
 - i. A majority of participants (62.5%) had engaged in some rudimentary form of rainwater harvesting before participating in the Low-Income Rainwater Harvesting Program

- ii. Typical drivers for historical collection of rainwater
 - 1. Household water usage and history of unreliable water sources
 - 2. Strategy for water usage irrigation for plants; vegetables, fruitbearing plants,
- e. Value of Water
 - i. Rudimentary forms of Rainwater Harvestings
- f. The extent of vegetation planting after installation of RWH
- g. Criteria for plant selection
- h. Irrigation Practices
