It was moved by Commissioner Lozano, duly seconded, [for the commission] to send a letter to the RTA [Regional Transit Authority] regarding the First Avenue Project, supporting Complete Streets[-based] decision to recommend a four-lane option versions a six-lane option.

An amended motion was made by Commissioner Lozano with the approval of the seconder (J. J. Lamb) and carried by a roll call vote of 15 to 0 (Commissioners Niblett, Otero, Walker, and Sadongei absent) [for the commission] to send a letter to the RTA [Regional Transit Authority] regarding the First Avenue Project, supporting the four-lane option versus the six-lane option. Our #1 recommendation would be to only do safety improvements with as few demolitions as possible, and failing that, we would support the four-lane option using Complete Streets guidelines (already outlined by Complete Streets), again with as few demolitions as possible.
