### Monday, January 10, 2022

# 2. <u>Approval of Historic Landscapes Subcommittee Minutes from Meeting of:</u> 12/17/21 (Discussion/Action)

Commissioner Lamb moved approval of the minutes, seconded by Commissioner Mulder and passed 4-0

#### 3. Review Cases

a. <u>Villa Catalina, 521 N. Country Club Rd., Landscape – Long-term landscaping plan</u>

The following vegetation substitutions were discussed, concerns raised and suggestions made.

- Turf as needed: substitution suggestions include Dalea x 'Sierra Gold' or the Rosmarinus officinalis 'Prostrata' or 'Huntington Carpet.'
- Juniper sp.: substitution suggestion include other low-growing juniper, Rosmarinus officinalis for texture, Simmondsia chinensis 'Vista.' Callistemon viminalis 'Little John' could also be a low juniper replacement. Juniper is also considered useful in its current context.
- Ligustrum lucidum: if hedged substitution suggestion is Buxus microphylla var. japonica. If foundation planting, Callistemon viminalis 'Little John.'
- Pittosporum sp.: substitution concern about intended height.
   Commissioner Lamb suggested selecting a shrub that does not require heavy pruning, as heavily pruned pittosporum will sunbum.
   Ms. Erickson pointed out that pittosporum fragrance is an important characteristic, especially in the desert. Substitution suggestions include other pittosporum, Euonymus japonicus, Myrtus communis 'Boetica.'
- Lantana camara mix: should be retained as historically used.
  Other cultivars can be considered.
- Bougainville sp.: substitutions should be made with reference to microclimates and location (especially at the entrance). Tecoma X 'Crimson Flare' might be an appropriate substitution in some cases.
- Leucophyllum frutescens: suggested substitution is another Leucophyllum of similar appearance.
- Nandina domestica: may be appropriate to retain. Substitution might include Hamelia patens 'Dwarf Red'
- Primrose jasmine: an appropriate species to retain if possible
- Tecomaria capensis: retained as possible. If a small shrub is needed then Justicia spicigera is suggested.
- Traditional annual beds: intended to offer color. Proposed plant selections are appropriate, excluding Echinococcus gursonii and Yucca rostrata.

#### b. Fort Lowell Park trees, 2900 N. Craycroft

Ms. Brown reported that the design team was not prepared to present at this time.
