- 1. Roll call to establish quorum** – Committee Chair Kelly Huber called the meeting to order at 3:33 p.m. Roll call was taken, and quorum was established (11-7).
- 2. Review & Approval of November 10, 2021 Meeting Minutes** – Committee member Terry Chandler moved to approve the November 10, 2021 Meeting Minutes. Committee member Kenna Smith requested a clarification on agenda item #8 and suggested amending the header to read as "Moratorium on Accepting New Art Donations" instead of "Moratorium on Donations". Committee member Terry Chandler agreed and accepted Ms. Smith's amendment. Committee member Maureen Lueck seconded the motion. The Meeting Minutes were approved by a roll call vote of 10-0-1.

- 3. Welcome & Chairperson's Report** – Committee Chair Kelly Huber welcomed everyone to the meeting and announced that she would be stepping down from her position as Committee Chair. Adriana Gallego, Executive Director for the Arts Foundation for Tucson and Southern Arizona thanked Ms. Huber for all her hard work, assistance, and dedication to the PACD Committee. Adriana Gallego, Executive Director for the Arts Foundation for Tucson and Southern Arizona provided a brief update on the relocation of the Five Points Cesar Chavez

statue. Ms. Gallego said a few different options are being discussed with City leaders and property owners. Discussion was held. No action was taken.

4. **Chairperson Position Change** – Adriana Gallego, Executive Director for the Arts Foundation for Tucson and Southern Arizona said nominations and elections would be held in February for a new Committee Chair and a Vice-Chair. Any and all nominations would be accepted now through February. Discussion was held. No action was taken.
5. **Multiple Upcoming Call to Artists** – Public Art Project Manager Wylwyn Reyes announced that there are multiple upcoming art projects from 2022 – 2025 through the Prop 407 Parks + Connections program. These art projects will vary from project to project and fall into both categories of Prop 407 (Parks and Connections), therefore the budget for each will vary as well. Mr. Reyes said multiple Call to Artists invitations would be scheduled and promoted, starting this Friday (January 14, 2022). Discussion was held. No action was taken.
6. **Michael Perry Memorial Park Art Damage and Accident** – Public Art Project Manager Woods Fairchild provided information and shared images of the art that was damaged at the Michael Perry Memorial Park due to an unfortunate fatal accident that occurred in December 2021. Ms. Woods said communication with the artists and the City of Tucson is being conducted to assess the damage and determine if repairs are possible. Maintenance, redesign, relocation, and budget are topics being discussed. Discussion was held. No action was taken.
7. **Stone Curves Successful Event** – Public Art Project Manager Wylwyn Reyes provided information and shared before and after images of the restoration of the Stone Avenue Curves Mural. He shared the names of the artists who worked on the original mural back in 2001 as well as those who recently worked on it in 2021 which also included a few youth artists. Mr. Reyes said there was a celebration as well with a great community turnout. Discussion was held. No action was taken.
8. **Free Wall Meeting Today** – Committee Chair Kelly Huber announced to the committee members that there would be a Free Wall meeting immediately after the PACDC meeting. Ms. Huber invited everyone, who wanted to participate in the Free Wall meeting, to remain on the current virtual Zoom link. Discussion was held. No action was taken.
9. **Call to the Audience** – No members of the public were present virtually, therefore no Call to Audience.
10. **Adjournment** – Committee Chair Kelly Huber adjourned the meeting at 4:19 p.m.
