**2. Introduction of new HRC Member; Melissa Gomez, Ward 2.**

The Cesar Chavez Holiday Coalition will host a vigil for laborers lost during the COVID19 pandemic, on March 31, 2022, at 6pm at the Rudy Garcia Park (5001 S. Nogales Hwy). There will be a community Ofrenda and the alter will be built by members of the community.

**6. Commissioners Summary of Current Events**

Reports were provided by Vice Chair Dalton and Commissioner Webb-Vignery. Additionally, Vice Chair Dalton, provided the following event information:

The Vice Chair Dalton through the University of Arizona will be hosting a talk with the Ukrainian Ambassador tentatively scheduled for March 30, 2022, 6pm, to meet with the Russian Studies Department.

**7. Subcommittee Reports and Discussion**

c. Diversity Report

Commissioner Smith indicated that he has contacted Pima County regarding some of the information he has been trying to obtain to provide a report to this commission.

He stated he was advised to utilize the Pima County/City of Tucson websites. Pima County asked for clarification on the information he is requesting. He indicated that he would resubmit through Pima County and follow up with The City of Tucson.

He will follow up with this Commission, once he has obtained the data he needs.

d. Human Rights Standards in Procurement

Vice Chair Dalton advised he has forwarded information to the Jaime Corrales, City Clerk support staff. He has asked Jaime to share these documents with the HRC as resource materials related to Human Rights Standard in Procurement.

**8. Update Regarding Commission on Gay, Lesbian, Bisexual, and Transgender Issues**

Commissioner Molina stated that the GLBT recently attempted to meet, but he did not attend that meeting.

Vice Chair Dalton stated that the GLBT Commission did not establish quorum.

**9. Census Data Analysis Discussion**

Chair Molina stated that there had a been a number of factors that affected the Census. The Pandemic, policy decisions related to citizenship and loss of funding for door walkers.

He stated that minority communities are disproportionately affected by these undercounts and how this is going to exacerbate funding levels that are already in place. He asked if there were ways to be heard in conversation; possibly a way for Mayor and Council to advocate at the Federal level on behalf of Tucson, to explain that it is not fair to use those counts, but rather, use extrapolations instead; looking at trends with more current data?

Commissioner Webb-Vignery suggested reaching out to the City of Tucson Legislative Liaison, to possible reach State and Federal Levels.

No formal action taken.

**10. Invitation of Police Chief Kasmar to attend HRC**

Chair Guzman stated that he has contacted Chief Kasmar's office. He asked the HRC, collectively, when would they like to see the Chief attend a future HRC meeting. The Commission agreed that they would like to see him attend as soon as possible.

Chair Guzman stated that he would follow up with a formal invitation to the Chief. He asked that once confirmation of his attendance was received, to please add this as an agenda item to the April 13, 2022, HRC meeting. He also asked that the City Clerk's Office please share meeting details with Chief Kasmar's office.

**11. Vacancy and Advisory Positions**

Chair Guzman combined Agenda Items 11 and 12 – as these are related.

## 12. Letter to Mayor and Council Regarding HRC Vacancies:

Chair Guzman stated that he has had communication with the Ward Offices with vacancies. He stated that there was a current application for Miranda Hicks to join the HRC, this was forwarded to Ward 1.

Commissioner Molina's also expressed his desire to join the HRC and resign his position to the GLBT. It was suggested that he complete the BCC application on the City of Tucson website; this would be processed and forwarded to the Ward 6 Offices, as they currently have a vacancy.

Jaime Corrales will follow up with Chair Guzman and Commissioner Molina when his application has been received, processed, and forwarded to Ward 6. Chair Guzman also suggested that Commissioner Molina reach out directly to Ward 6 and express his interest in representing Ward 6 in the HRC.
