*The Complete Streets Coordinating Council moves to recommend that:*

- *The City of Tucson advances the three-lane option on the 5th/6th Street Complete Streets Project.*
- *The CSCC makes this recommendation because the three-lane option will improve safety and traffic flow, while also providing additional travel choices along 5th/6th Street.*
- *This project will improve the aesthetics and comfort for all modes of travel.*
- *These improvements can be realized without major increases in delay to the driving public, including emergency response, as traffic volumes on all major segments are well within the thresholds that the City uses to determine the feasibility of reducing travel lanes.*
- *The three-lane alternative is also consistent with the Move Tucson improvement recommendation for 5th/6th Street from Campbell to Wilmot*
