NEW BUSINESS

11. SB 1165 "Save Women's Sports Act" ACTION ITEM(S)

• Would prevent transgender girls in grades K-12 from playing on girls sports teams. Request from Chair for commission stance on these bills, and an action to take. SM comments that a single letter with all topics included to Mayor and Council. MW asks for consensus on a digital letter to M & C. SM: can this commission send letter directly to Governors office? JD shares that a resolution can be created and shared directly to M & C or Gov office. The Mayor can reach out to Gov directly (and publically) and encourage non-action, delay, or veto.

12. SB 1138 (Has Passed 1 Chamber) ACTION ITEM(S)

• Would bar physicians and other providers from providing gender-transition surgery to anyone under 18 years old.

13. HB 2161 (Has Passed 1 Chamber) ACTION ITEM(S)

- Would bar school districts and charter school employees from withholding or concealing information from or facilitating, encouraging or coercing students to withhold or conceal information from the student's parents about the student's physical, emotional or mental health.
 - A student's discussions with a teacher about gender identity and/or sexual orientation could be considered information about the student's health. Schools that fail to comply could be sued.

14.Other Anti-LGBTQ Bills Currently Proposed in Arizona:

- o Have been assigned to committee:
 - SB 1045 would prohibit public or private school employees from "coercing" students into keeping their identity from their guardians. The bill did not make it out of committee.
 - HB 2011 would require students to seek their parents' permission before joining any student group or club involving "sexuality, gender or gender identity."
 - HB 2285 would prevent school districts and charter schools from providing sex education or AIDS education before sixth grade and emphasize biological sex not gender identity.
 - HB 2292 would require birth certificates to only use male or female markers.
 - HB 2293 public schools would not be required to use a student's gender pronouns that differ from the sex listed on a student's birth certificate.

- HB 2314 use of restrooms, changing facilities and sleeping quarters at public schools would be limited to biological sex assigned at birth.
- Have not been assigned to committee:
 - SB 1130 would ban gender-affirming health care for Arizonans younger than 18.
 - SB 1046 would designate sports teams into men's, women's and coed based on "biological sex."

MW suggests definition of the commission's stance on all previously listed SB/HB. Motion by: Jess Patrick in opposition of all previously listed HB/SB. SM seconds. Motion passes unanimously 6 in favor 0 opposed to the motion. Method of approach: digital letter to M & C sent as soon as edited to convey commission's opposition to these bills.
