#### 2. Approval of May 4, 2022 meeting minutes

Bobby Verenna put forth a motion to approve the minutes. Andrea Leisner seconded the motion. Motion passed, all in favor.

#### 3. Committee Review and Scoring or Proposals

### A. Special Events

Akanni Ogebola and Bobby Verenna had conflicts of interest (ATO Management: South Tucson Street Festival and Perimeter Bicycling Association's El Tour de Tucson, respectively) and recused themselves from voting on the Special Events proposals.

Fourteen proposals were submitted by community organizations for special events, with requests for funding totaling \$497,000.

Committee members discussed the proposals, agreeing to:

- 1. Fund events that produce the most economic impact
- 2. Preserve cultural events
- 3. Be mindful of those events not ready for "prime time"
- 4. Consider parallel funding that they are receiving
- 5. Consider if the amount requested would "make or break" the event

David Godlewski put forth a motion to remove the Arizona Tech Council from funding consideration, and fund organizations at either \$5000 or \$10,000.

The committee wanted more discussion on the amounts for each organization, so David Godlewski withdrew his motion.

After discussion, the committee agreed to the following event funding allocations, totaling \$140,000:

Jazz in January: Tucson Jazz Festival: \$15000

Tucson City of Gastronomy: Pueblos del Maiz Fiesta: \$10000 Southwest Folklife Alliance: Tucson Meet Yourself: \$15000 Tucson Rodeo Parade Committee: Rodeo Parade: \$15000

David Godlewski put forth a motion to approve the funding allocations above. Andrea Leisner seconded the motion. Motion passed 5-0.
