Member Ramirez duly seconded the motion. **Discussion:** None. The motion passed on a roll call vote of 4-0

- 5) Water Policy Discussion Chair Shipeck requested Candice Rupprecht, City of Tucson Water Department Conservation Superintendent, to lead the discussion. Mrs. Rupprecht shared a memorandum sent to Mayor and Council from Tucson Water Director Kmiec. Mrs. Rupprecht updated the committee with the direction given to Tucson Water at the June 7, 2022, Mayor and Council meeting to include five policy considerations.
  - **a)** Modifying the building code requires using EPA Water Sense certified fixtures in new construction.
  - **b)** Low-Impact Development ordinance, implementation of green stormwater infrastructure in new residential construction
  - c) Requiring irrigation meters for commercial and multifamily properties over specified size/use thresholds.
  - **d)** Requiring submetering for townhome and condo developments.
  - e) Implement a Net Zero Water approach for new development.

The committee was asked to seek additional conservation actions in addition to the drought plan and reviewed a list of policy considerations. Members were given an opportunity to question and comment on the policies and offer feedback to the department. Mrs. Rupprecht requested the committee provide additional stakeholders for Tucson Water to contact and members to consider their professional expertise and provide feedback to the department.

- **6)** Future Meetings / Agenda Items Chair Shipeck opened the discussion for members to identify future agenda topics for the committee. Those items reviewed and discussed were:
