Legal Action Report and Meeting Minutes

Call to Order/Roll Call 1.

The meeting was called to order at 2:00 p.m. by Chair Washburn. Those present and absent were:

- 2. Announcements - Chair Washburn had technical difficulties and requested Mrs. Jessica Rodriguez to assist in running the meeting. Chair Washburn requested a moment of silence for the victims and the families of the Uvalde, Texas, shooting.
- 3. Review & Approval of April 21, 2022, Legal Action Report and Meeting Minutes - Member Stratton moved to approve the Legal Action Report and Meeting Minutes; member Juneman duly seconded the motion. The motion passed on a roll-call vote of 3 - 0.
- 4. FY23 CIP and Operating Budget - Amber Kerwin, Tucson Water Business & Organizational Support Services, Rates Manager, presented the Budget Reguest topics: Operations & Maintenance (O&M), annual Capital Improvement Projects (CIP), and Supplemental Requests for onetime costs. Mrs. Kerwin shared information on the Water Operating Funds; critical points of interest were the cost increases for Central Arizona Project (CAP) and staff compensation due to market-based adjustments. The Conservation Program showed a decrease in FY23 requested budget, which was shifted into the Water Conservation Rebate Program. The Storm to Shade program is funded through the Green Stormwater Infrastructure fee.

- 5. Rate Indexing discussion Amber Kerwin, Tucson Water Business & Organizational Support Services, Rates Manager, opened the discussion for member comment. Mrs. Kerwin outlined the comparison benefits and risks for member discussion and comment. Indexing rate increases topics included:
 - Benefits
 - o Guaranteed annual revenue increase
 - o Cost increases can be tied to indexes for labor and materials
 - o Easier public messaging and increased transparency
 - Time reductions for water staff and automatic increases for M&C
 - Risks
- Periods of low inflations create insufficient indexed rate increases
- No perfect fit index leads to additional increases complicating public messaging
- o Indexes would not account for outlier events or challenges, for example, PFAS remediation
- Selecting the best fit index

No action was taken on this item.

- 6. Call to Audience Member Basefsky advised the committee the Central Arizona Project (CAP) would host the CAP university on June 20 and do a deep dive into the shortages. On June 23, CAP would do a shortage briefing, including the municipal stakeholders. The briefing would be available in person and on the CAP website.
