# **MEETING MINUTES**

1. Call to Order/Roll Call – Commission Chair Dale Calvert called the meeting to order at 5:36 p.m. Roll call was taken, and quorum was established, 6-4.

- 2. Approval of Minutes April 25, 2022 Commission member Al Wiruth made a motion to approve the April 25, 2022 meeting minutes with a few recommended edits. Commission member Cindy Harper-Ayala seconded the motion. Edits were applied and the meeting minutes were passed unanimously by a roll call vote of 7-0.
- **3.** Call to the Audience No members of the public were present, therefore there was no Call to the Audience. Commission member Cynthia Harper-Ayala requested that the next BOC meeting be in person.

This is the time when any member of the public may address the 2012 Bond Oversight Commission. Due to time constraints, the total time allocated for this is 10 minutes. Individuals are allowed three (3) minutes each. Due to Open Meeting Law, Commission Members cannot discuss topics that are not on the agenda. Items brought up by the public may be considered as an agenda item for a future meeting.

#### 4. Prop 101 Updates

- a. Financial Reports Jeffrey Whiting, Finance Manager with the City of Tucson presented financial reports and provided an overview update on revenue collections and expenditures through the end of the Fiscal Year, June 30, 2022. Mr. Whiting said that year to date through Fiscal Year 2022, the program has collected \$28,781,494. When added to the previous amount collected of \$94,494,942, the grand total is \$123,276,436. The program had originally predicted to collect \$100,000,000, giving the program a surplus of \$23 million. Current program expenditures are \$55,005,777, with \$4,934,649 encumbered, leaving a balance of \$40,059,575 to complete road improvements as promised. Mr. Whiting discussed the budgets for each of the different project packages. The projected budget for the Arterial Street packages was \$62,224,893, but current projections show that \$64,009,148 is needed to complete these projects. He said the projected budget for the Local Streets packages was \$40,148,518, but current projections show That \$43,421,933 is needed to complete these projects. The increase is due to the rising cost of construction materials and supplies. Fortunately, the overages would be covered by the surplus revenues that were collected. Report was given. Discussion was held. No action was taken.
- **b.** Arterial Street Project Updates Sarah Spencer, Engineering Project Manager with the City of Tucson, provided updates on the Prop 101 arterial rehabilitation and fog seal arterial roadwork projects. Report was given. Discussion was held. No action was taken.

- Bid advertise in December 2022, may combine with Fog Seal Package 11 as one construction contract

#### Rehab Package 10 – FY23

- Main, 10th Avenue, Cushing, Alameda, Pennington, Church, Franklin, Stone
  - Church Avenue Complete Street will be combined with pavement rehab work into one construction project, road diet to be incorporated in striping plans, consultant is Psomas
  - $\circ$  Kimley-Horn is design consultant for all other routes
  - Cushing St being advanced for 2022 El Tour (construction to start in mid-September and be completed by end of October, El Tour is November 19)
- In design, 60% striping layouts submitted July 15 for review
- Design completion in December 2022, construction scheduled for summer 2023

c. Local Street Project Updates – Austin Wesnitzer with the Tucson Department of Transportation & Mobility gave an update on local street projects. Report was given. Discussion was held. No action was taken.

**Package 1** – Green Acres Estates, Tanque Verde Country Estates / Bear Canyon Woods and Tanque Verde Acres - Construction is complete, and project is closed

**Package 2** – Paseo Vista and Vista del Pueblo, Mission Manor / and Rita Manor and Country Club Park - Construction is complete and additional ADA ramps are being priced and will go to bid and completed alongside the remaining ADA ramp work for packages 7 and 8.

**Package 3** – Rancho del Este and Camino Real Estates and Olive Grove - Construction is complete and project is closed.

**Package 4** – Carriage Hill, Centennial Park, Hiawatha Hills, Teresa Terrace and Westgate Townhouses – Construction is complete, and the project is in closeout

Package 5 – National City and Whitestone Addition – Construction is complete

**Package 6** – Speedway Addition No. 1, Fairmount Addition and Casa Bonitas and Cottonwood Lane - Paving is complete in both neighborhoods, ADA ramps are complete, and project is in closeout

**Package 7** – Miracle Mile Manor / Mesa Verde and Coronado Heights - Bid documents are being updated with current market costs with anticipation of the work going to procurement at the end of May with construction beginning early fall.

**Package 8** – Valley View East and Centennial Park and Estes Park - Bid documents are being compiled with anticipation of the work going to procurement at the end of May with construction beginning early fall.

- 5. Citizen Request Log Mike Graham with the Tucson Department of Transportation & Mobility (DTM) said there were 56 new additions to the Citizen Request Log since the last meeting on April 25, 2022 to July 19, 2022. Report was given. No action was taken.
- 6. Future Meeting Date/Format and Agenda Items Commission members discussed and agreed to have their next meeting on October 17, 2022 at 5:30 p.m. with the possibility of meeting in person. Mike Graham said he would clarify with the City Clerk's office on the meeting format (virtual, in-person, or hybrid). Commission member Ian Johnson requested, as a future agenda item, the commission discuss excess funds and the road improvement treatment types from Prop 101 and the opportunity to provide input on proposed areas for improvements. Commission member Al Wiruth requested an update on the pilot roadway treatments applied on the westside of town and an update on Prop 411.
- 7. Adjournment Commission Chair Dale Calvert adjourned the meeting at 7:15 p.m.
