- Presentation by Sarah Darr -City of Flagstaff Housing Director on Housing and Market needs regarding applying for housing bond election, along with educating the committee on Prop 442 on a federal and state level along with implementing the programs funded by Prop 442.

B. Housing First -

- Joanna Carr gave a presentation on Tenant Protection throughout the United States and integrating this tenant protection without any preemption or legal liability with the Landlord Tenant Act.

C. Affordable Housing –

- Discussion held on the pipeline and affordable housing. The market on profit and non-profit developer. Also developing a 5-year affordable housing goal.
