1. CALL TO ORDER

• Meeting called to order at 3:30 p.m. by R.van Ommeren; verbal roll call – 8 members present, quorum (N.Casebeer arrived after role call).

2. Minutes and LAR for Approval

• Motion to approve October 19, 2022 minutes and Legal Action Report. Motion for approval of Oct. 19, 2022 minutes by F.Sandoval, second by R.Field; motion passed: verbal aye/approved=8, no=0, abstain=0

3. Discussion

A. Blue Palo Verde Moratorium Discussion: R.van Ommeren provided update on discussion w/ Dr. Ursula Schuch and Judith Brown on research and findings; PCR testing showing RNA presence; best if testing done in batches, cost benefits; can accommodate up to 95 samples at a time; most effective time to test – when leaves present on trees; some plants may have virus but asymptomatic; due to grant, current testing free to commercial growers; Foothills, Palo Brea and Desert Museum not show symptoms, found in Mexican Palo Verdes; virus can be transmitted via seeds; vector is mites; mites concentrate on broom portion of trees growers should be cautious where they get seeds from; funds for testing available through 2024

Discussion: what does it mean to lift moratorium; affects only city properties; obtain trees from nurseries that have voluntarily tested; serious growers will look to test annually; lifting moratorium – adding Blue Palo Verde back on to selection list (to an already limited palette); contractors need to guarantee stock for 3 years (tho currently city has been down to 2 yr guarantee); staff should be able to spot within one growing season, if broom present; contract spec's to add replacement if tree shows symptoms within establishment period; what would special provision look like, certain nurseries that are testing be on the approved purchase list; will continue discussion regarding special provisions – what will be spelled out. Motion: by R.Field to lift moratorium contingent on proof of neg test of random sampling of nursery growing stock within last 12 months, withdrawn, pending further discussion on special provisions. Continue discussion in Feb. meeting. No Action.
