FIRE MINUTES 02/02/2023 • June 30, 2022, Actuarial Valuation Reports- Summary of Key Results

Mr. Jesse briefly discussed the PSPRS June 30, 2022 actuarial valuation results for Tucson Fire and Tucson Police. Those results determine the FY 2024 employer contribution rates. The Tier 1/Tier 2 employer contribution rates effective July 1, 2023 (FY 2024) will be 76.58% for Fire and 93.28% for Police. The Tier 3 employer contribution rates will be 72.95% for Fire and 91.70% for Police.
