**Mission and Purpose of the TPCBAC:** The Bicycle Advisory Committee meets and confers with representatives from local transportation departments, providing opinions and advice on community concerns relating to bicycling. The committee is a voice for the region promoting best practices in bicycle safety and bicycle awareness. Additionally, it provides a conduit for citizens to voice their concerns and express their needs to local government. It acts as the official advisory agency to the city and county governing bodies for technical questions and concerns related to bicycling and reviews and makes recommendations regarding any proposed local, state, and federal legislation related to bicycling.

**Major Accomplishments in 2022:** The committee continues to be a voice for the region promoting best practices in bicycle safety and bicycle awareness. The committee continues to provide input to the City's Move Tucson program. It contributed to the City's Complete Streets Coordinating Council and participated in several activities related to that project.

The advisory committee regularly gives feedback to the County on Loop safety and needed improvements to the Loop. In addition, the committee provided feedback to Pima County Flood Control/Parks and Rec. in response to a request regarding e-bicycles on the Loop.

The bicycle advisory committee continues to contribute to City and County efforts toward providing citizens with equitable access regardless of their mode of transportation.

The committee provided a recommendation to the City of Tucson, Pima County, and the other municipalities represented on the committee regarding the encouraged use of protected bicycle intersections whenever feasible when road construction occurs at major intersections.

The committee regularly provides input on road construction projects in order to facilitate bicycle safety in those areas and to recommend best practices. We have brought bicycling concerns to the attention of the Arizona Department of Transportation when they come up, and recently regarding the I-10 expansion. Meeting opportunities continue to be limited and challenging due to the continuing pandemic and the requirement to meet remotely. Interaction with the public and our local partners from the cycling community were also limited due to Covid restrictions on their operations and activities, and the move to virtual meetings as well.

The committee has made efforts to improve communication with the public by providing a comment and question option on the public website for the committee.

#### **Work plan for the coming year:**

- The committee will continue to be a voice for the region promoting best practices in bicycle safety and bicycle awareness.
- The committee will continue working to identify and address issues that restrict or limit access to cycling or that affect safety outcomes in Pima County.
- It will continue to contribute to the City of Tucson's Complete Streets Project having recently appointed a committee member to that commission.
- The committee will seek opportunities for providing its transportation partners with input that contributes to improved conditions for all road users.
- The committee continues its commitment to build relationships with city, county, and municipal entities to ensure effective communication between those entities and the committee, consistent with its mission to recommend to those entities ways to ensure those decisions that affect bicyclists are brought to their attention.
