#### 6. Tucson Police Department: Lt. Jesse Cornia

A. Lt. Jesse Cornia presented in place of Asst. Police Chief Diana Duffy who was out. Lt. Cornia ran stats of TPD external complaints from 2017 to present day 2023. The Police Department has seen a downward trend of external complaints since 2019. The number of sustained complaints is the main concern when gathering external complaint statistics. Lt. Cornia said he will provide statistics of sustained complaints for the years that were referenced at this meeting, year 2017 through 2023.

# 7. Office of Independent Police Auditor

Mitch Kagen / Independent Police Auditor reported:

Mitch Kagen spoke briefly about Xylazine, which is being mixed with fentanyl. The drug Xylazine has also shown resistance to Narcan. He also spoke about two officer involved shootings being investigated by OPS. Mr. Kagan recommended doing a 4 hour ride-along and informed members that any substation could organize a ride-along. Mr. Kagen reported on the continued case reviews, conferences coming up and stated it was all business as usual.

Traci Hockett would like someone from TPD to come in and address the homeless issue and citizens' rights in regard to the issue. Vice Chair Nunez is curious about a possible presentation with a TPD member and the City Attorney's Office regarding Citizen rights while recording Police.
