5. Relocation Subcommittee Recommendation *AD 7.01-7* Ocean's Garden – Adaptive Rec Center, Reid Park

Abby Christensen, Public Art Collections Associate, presented the subcommittee's recommendation to support the relocation of the outdoor portion of the Ocean's Garden artwork at the Edith Ball Adaptive Rec Center in order to accommodate the upcoming parking lot construction at the Reid Park Zoo area. One particular mosaic is located in the shade structure outside which will be removed to accommodate the upcoming construction and the relocation plan is for the artist, Nina Borgia-Aberle, to refabricate the mosaic artwork and install it on the outdoor portion of the entry way of the rec center. The new location maintains the existing relationship between the outdoor piece and the pieces inside the rec center. Jim Glock asked if it was a demolition and a reconstruction. Abby confirmed that it was. Chair Jimenez asked how it was considered a relocation if it will be demolished and refabricated. Abby said it qualifies as a relocation because it is only one portion of a larger artwork that will be refabricated and reinstalled in a different location.

Motion to approve the relocation recommendation was made by Felix Lawrence and seconded by Anne Lopez. The motion passed with a unanimous vote.



Santa Cruz River: Irvington to Drexel PA C142

Wylwyn Reyes, Public Art Manager, presented an overview of the artist selection and panel review process. He presented that the panel for the Santa Cruz River: Irvington to Drexel project recommended Pete Goldlust & Melanie Germond to be the artists for this project. Felix Lawrence asked if the PACD committee provided any direction or guidance to the panel for this project. Wylwyn said the Pima County Regional Flood Control District and Engineering





Division collaborated with AFTSA to assemble the panel and provide guidance. Corinne Cooper asked if there was an image of the proposed artwork. Wylwyn said no, the design of the artwork happens after the artist is selected. Chair Jimenez asked Wylwyn to explain the difference between the 1% funding for artwork from the City and Pima County. Wylwyn said they both come from different funding sources, each with their own directives/requirements from the City and Pima County. Felix Lawrence asked if the PACD committee provided any direction to the panel/panelists prior to the selection. Wylwyn said there were no proposals to provide direction for and the role of the PACD is to ensure the AFTSA is following the rules and guidelines provided by the City and Pima County. Wylwyn also said Chair Jimenez was asked to be on the panel but unfortunately, she could not be on the panel. Lara Somers asked if the artist was local. Wylwyn said no. Corinne Cooper asked if being on a panel is limited to your regional area of representation. Wylwyn said not necessarily.

Motion to approve the artists selected was made by Felix Lawrence and seconded by Maureen Lueck. The motion passed with a roll call vote of 10-1.
