1. CALL TO ORDER

• Meeting called to order at 3:30 p.m. by R.van Ommeren; verbal roll call – 9 members present, quorum present (D.Davis logged on 3:44 p.m.)

2. Minutes and LAR for Approval

• Motion to approve April 19, 2023 minutes and Legal Action Report by K.Schug, second by R.Field; no discussion; motion passed: verbal aye/approved=9, no=0, abstain=0

3. Discussion

- A. Blue Palo Verde Testing Discussion: Moratorium was lifted at last meeting; N.Shipley discussion of Civano's growing protocol: (1) need to start with clean seed, mother tree should be tested annually (2) clean nursery do not bring stock from other nurseries (3) spray every 2 weeks (4) sterilize equipment between trees, SaniDate (5) dispose of whole plant if find witches broom, bag and dispose off property, (6) log and method of disposal; make protocol available to other nurseries. Discussion: get memo out to ANA and recommended protocol: may have some middle steps missing, how to find mother tree, why is rotating miticides important, what would city need need to check with staff purchasing; usually very obvious within short period of time if tree has witches broom as it will be the new growth; who on city end will keep an eye on the new growth?; good to have higher criteria for what sorts of tree are being installed in the city; subcommittee to discuss protocol Rebeca, Nick, Jenny; try to get into ANA and ALCA newsletter
- B. LAC open member positions: 2 positions = Educator and Contractor: meeting with 3 applicants today. Contractor=Emma Stalh-Wert- focused on rainwater harvesting 809 years, certified arborist, interest in big picture, was part of WMG Monsoon Squad, did rough draft of city's tree care; Contractor= AJ Ragnow certified arborist, tree work for 5 years, also contracted in Seattle and Denver, bilingual, educate companies how little needs to be pruned, boots on the ground experience, this committee

- experience is new to me; Educator=Erin Posthumus, environmental biology, working with USA Phenology Network, projects with Tucson Audubon, volunteers with Arizona Sonora Desert Museum, puts together training material, how to do data collection, reports to public, work on a wide range of projects from local to state to federal level, lots of science communications and interpretations. Discuss candidate recommendations next meeting.
- C. Urban Forest Action Plan: any additional feedback for Nicole; would like support of plan from LAC; this is a Plan, does not include implementation. Discussion: general like the plan, future will have additional materials to educate public. Motion to support the Draft Urban Forestry Action Plan by A.Meadow, second by R.Field; passed 9-yes, 0-no, 0-abstain (D.Davis left).

- E. City Updates: DTM D.Marhefka provided updates to various roadway, including resurfacing projects and need to prune trees due to accessibility of re-pavement machines, D.Marhefka overseeing contractors.
