Approve May 17, 2023 minutes and Legal Action Report; scribner corrections – 3.B. "Emma Stahl-Wert . . . 8-9 years"; motion to approve by N.Casebeer, second by F.Sandoval; no discussion; motion passed: verbal aye/approved=7, no=0, abstain=0

3. Discussion

- A. Summer LAC schedule & In-Person meetings: Discussion regarding summer month off; Nichole not here in July, Jenny not here in Aug; Ron preference Aug; Kasy either; Alison no strong preference. Discussion: what does Educator position do, no specific definitions, is it more about communications who is audience (have dealt with ADWR, M&C), opportunity for growth in different areas, past representatives were connections to Ag Extension; recap of Eric and Erin both strong candidates, Eric expressed equity lens, from Tucson, strong science background; Erin strong science background, skill in science communications/getting things done, did not express as strong in community engagement & equity. Everyone would be happy

with both. Motion to recommend Eric Dhruv for Educator Representative by N.Casebeer, second by J.Moscato; passed yes=9; no=0; abstain=0.

Landscape Contractor discussion: 3 candidates: Petr is with a large contractor and does work within the city, lengthy knowledge, could help LAC better understand contractor's role, could provide insight how large contractors operate; Emma and AJ strong on smaller scale green stormwater infrastructure installations, Emma has lead workshops on green infrastructure to city workers; all members felt all 3 candidates would bring value to the committee with different perspectives. Motion to recommend Petr Chylik for Landscape Contractor by N.Shipley, second by K.Shug, passed yes=9, no=0, abstain=0.
