Mr. Jesse said that the last of the pension contribution files for FY 2023 had posted to the City of Tucson internal pension administration system earlier in the morning. He said he had finally been able to work through the Workday implementation challenges in getting the files generated accurately. Mr. Weber thanked Mr. Jesse and his staff for their hard work in making that happen.

Mr. Brandt asked about the possibility of making a motion to change the meeting schedule from the first Thursday of the month back to the first Tuesday of the month. Mr. Jesse said that would not be possible at the current meeting because the topic was not listed on the agenda. Mr. Brandt asked that it be placed on the August 3 meeting agenda for consideration. Mr. Weber, Mr. Adler, Mr. Ewings, and Mr. Fimbres indicated their support of the suggested agenda item. Mr. Fimbres asked about the effective date of any adopted change and the creation of a new meeting calendar. Mr. Jesse explained certain steps would first be required including filing documents with the City Clerk and getting the meeting location rescheduled. Mr. Brandt asked if it would be easier should any adopted change to the meeting schedule be made effective January 1, 2024. Mr. Jesse said he thought so. Mr. Fimbres asked Mr. Jesse his opinion about the best approach. Mr. Jesse said he takes direction from the Police and Fire Boards and could execute whatever decision was reached, but his opinion was that should a change be adopted it would be much cleaner if made effective January 1, 2024.
