We further recommend that per code all potential code or process changes requested by City of Tucson or Pima County staff be referred to the joint Tucson–Pima County Historical Commission for guidance and direction. Finally, the Commission recommends that the intergovernmental agreements between the City of Tucson, Pima County, and the City of South Tucson be maintained.
