Members asked questions; Director Kmiec fielded questions throughout his report to clarify information for the committee and provide important information on water matters.

- 6) ****Proposed Commercial & Industrial Rate Changes** Amber Kerwin, Tucson Water Rate Manager, provided the committee with an overview of the proposed changes; the items reviewed and presented were:
 - a) Mayor and Council Direction
 - b) Current Structure Overview
 - i) Review of sample accounts
 - c) Proposed Changes
 - i) Rate Impact changes
 - ii) Customer Impacts
 - iii) Sample account reviews
 - iv) Rate Comparisons

The committee held an open discussion. Staff's recommendation: "The committee may vote on which proposed commercial and industrial rate structure change they support, 1A or 1B."

Motion: Member Hendel moved to support option 1B. Member Shipek duly seconded the motion. Discussion: Member Jones had concerns about the effects of hospitals and unintended consequences; her preference is to support option 1A. Member Mckenna did not support option 1B based on impacts to schools and possible reductions in funding and understanding of the impacts or the extremity of the impacts. Member Shipek wanted to ensure any recommendations offered enhancements to conservation programs. Chair Juneman did not have enough information to support 1B. The motion failed on a roll-call vote of 2 - 6.

Chair Juneman called for the pleasure of the committee, reminding the committee this item is the request of the Mayor and Council for feedback.

Motion: Member Lal motioned to support option 1A. Member Shipek duly seconded the motion. Discussion: Member Jones felt the motion was more palatable and remains concerned with impacts. Chair Juneman acknowledged the concerns and comments from the Finance subcommittee regarding the tiered changes. Member Gerlak spoke to the concerns of a vote without knowing who would be impacted. Member Juneman reiterated the changes for option 1A, which seemed to be a smaller change to customers. Member Little does not support 1A, based on a series of rate increases impacting customers. Member Little also encouraged Member Shipek to make another motion exploring conservation programs for commercial and industrial users. The motion passed on a roll-call vote of 7 - 1.

Chair Juneman advised he would draft a memorandum supporting Option 1A and add comments supporting the exploration of Conservation Programs for Commercial and Industrial Users. A review of the memorandum can be included in the October agenda.
