**CITIZEN'S COMMISSION ON PUBLIC SERVICE
AND COMPENSATION (CCPSC)**

CREATED BY:

Tucson City Charter, Chapter V, Section 9.1

MEMBERSHIP / QUALIFICATIONS:

Membership shall consist of seven (7) members are qualified electors of the City and who shall serve without compensation.

Members will be nominated from the community at large after the city publicly advertises for nominations from interested organizations or individuals.

Appointments from these nominations shall be made by the City Manager and shall serve for two-month terms.

FUNCTIONS:

The Commission shall, during its two-month term, conduct a review of the salaries of elected city officials. Such review shall be made for the purpose of determining and recommending the appropriate salaries commensurate with the duties and responsibilities of the positions covered by such review.

At no time may the Commission recommend a salary for the mayor which exceeds one and one-half (1 ½) times the salary set for members of the Pima County Board of Supervisors pursuant to A.R.S. §11-419(A).

The Commission shall file, no later than March 15th, a report of the results of each review conducted by the Commission together with its recommendations. The city clerk shall post the Commission's report in a prominent position at the office of the city clerk for a period of thirty (30) days subsequent to the filing of the report.

The Commission's salary recommendations shall be placed on the ballot for voter approval or rejection at the next general election, and shall be effective only if approved by a majority of the voters voting thereon. If the recommendations are rejected by a majority of the voters at the next general election, the salaries for elected city officials shall continue at their pre-existing levels.

QUORUM:

*Pursuant to Tucson Code, § 10A-140(a) this BCC is designated as "Category 1," for which a majority of the members currently *appointed and serving* shall constitute a quorum.

TERMS OF OFFICE:

Two-month terms beginning on January 15th and terminating on March 15th.

APPLICABILITY OF TUCSON CODE CHAPTER 10A, ARTICLE XIII:

All provisions of TCC Chapter 10A, Article XIII are applicable. T.C. § 10A-134(c) Appointees, except for advisory members and members of the technical code committees named herein, may not serve on more than two (2) bodies at a time.

OPEN PUBLIC MEETING LAW REQUIREMENTS:

This public body is defined as an advisory committee and must comply with all of the provisions of the Open Public Meeting Law

Historical Notes:

December 4, 2018 – Ordinance 11599, amended the Tucson Code, Chapter 10A-134(c) allowing members to serve on up to two (2) BCC's Simultaneously.
