MEMBERSHIP / QUALIFICATIONS:

Membership shall consist of nine (9) members, who shall serve without compensation and are appointed as follows:

- 1) Mayor and each Council Member shall appoint one member each.
- 2) City Manager shall appoint one member.
- 3) One member from the City Manager's Office will act as a facilitator, chair the committee meetings, and also be permitted to vote.

The membership shall represent diverse sectors of the community such as other government agencies, large companies and small businesses representing various industries, non-profit organizations, workforce development, and education.

All appointees shall be residents of Tucson, or have their primary business address located in Tucson, or both.

The Committee may form subcommittees as may be necessary to carry out its duties and functions.

FUNCTIONS:

- a) Establish a process for reviewing submitted proposals;

- b) Select proposals that best meet the priorities as stated in the request for proposal and that best achieve the desired performance measures;
- c) Recommend proposals to be approved and amounts to be allocated;
- d) Request and receive reports from the Independent Audit and Performance Commission on agency performance and utilize those reports when examining future proposals.

QUORUM:

*Pursuant to Tucson Code, § 10A-140(a) this BCC is designated as “Category 1,” for which a majority of the members currently *appointed and serving* shall constitute a quorum.

TERMS OF OFFICE:

Terms of the Committee members are consistent with the term of the Committee, which will automatically terminate on September 1, 2024.

APPLICABILITY OF TUCSON CODE CHAPTER 10A, ARTICLE XIII:

All provisions of TCC Chapter 10A, Article XIII are applicable except 10A-134(c) and (f) and § 10A-139(c) (5). T.C. § 10A-134(c) Appointees, except for advisory members and members of the technical code committees named herein, may not serve on more than two (2) bodies at a time.

The member from within the City Manager’s office is authorized to act as a facilitator, chair the committee meetings, and vote

No annual report is required.

OPEN PUBLIC MEETING LAW REQUIREMENTS:

This public body is defined as an advisory committee and must comply with all of the provisions of the Open Public Meeting Law.

August 7, 2012 – Mayor and Council passed and adopted Resolution 21937, amending Resolution 21802, to extend the term of the Economic and Workforce Development Selection Committee (EWDSC) to September 1, 2013.

August 6, 2013 – Mayor and Council passed and adopted Resolution 22110, amending Resolution 21937, to extend the term of the Economic and Workforce Development Selection Committee (EWDSC) to September 1, 2014.

June 21, 2016 – Mayor and Council passed and adopted Resolution 22586, approving the Economic and Workforce Development Selection Committee's (Committee) recommendations for Fiscal Year (FY17) allocations; amending Resolution No. 21605 to extend Committee's term to September 1, 2018.

July 10, 2018 – Mayor and Council passed and adopted Resolution 22922, amending Resolution 21937, to extend the term of the Economic and Workforce Development Selection Committee (EWDSC) to September 1, 2020.

December 4, 2018 – Ordinance 11599, amended the Tucson Code, Chapter 10A-134(c) allowing members to serve on up to two (2) BCC's Simultaneously.

January 17, 2020 – Article XIII § 10A-139(b) (5) corrected to Article XIII § 10A-139(c) (5).

June 30, 2020 – Mayor and Council passed and adopted Resolution 23191, amending Resolution 22922, to extend the term of the Economic and Workforce Development Selection Committee (EWDSC) to September 1, 2022.

July 12, 2022 – Mayor and Council passed and adopted Resolution 23481. Amending Resolution 23191, to extend the term of the Economic and Workforce Development Selection Committee (EWDSC) to September 1, 2024.

**August 8, 2023 – Ordinance 12024, amended the Tucson Code Chapter 10A, Article XIII to add a new Tucson code Section 10A-140, defining different quorum requirements for two specified categories of Boards, Committees, or Commissions.*
