Wylwyn Reyes, Director of Public Art, presented an overview of the artist selection and panel review process. He said Joaquin Murrieta Park, located in Ward 1, would be receiving park improvements in accordance with Prop 407 Bond funds which includes funding for public art. Park improvements will take place from 2023-2025. The public art budget is \$97,398. Public art opportunities include sculptures and murals throughout the main areas of traffic flow. He talked about the panel members and who they represented. Committee member Lara Somers was also on the panel. He presented that the panel for the Joaquin Murrieta Park PA project recommended two applicants out of 104 applications, Hirotsune Tashima (local sculpture) and Flowers & Bullets (community-based muralists), to be the artists for this project. Discussion was held.

Committee chair Alex Jimenez asked to clarify if the artists would be working together or separately. Wylwyn said separately on different projects. Lara commented that she is excited for both projects (park improvements and public art) at the park and enjoyed being on the panel and part of the selection process.

Motion to approve the artists selected was made by Maureen Lueck and seconded by Anne Lopez. The motion passed with a roll call vote of 11-0.

6. Public Art Donation Approval

Pueblo Gardens Curb Extensions

Abby Christensen, Public Art Collections Manager, presented an overview of the Pueblo Gardens Curb Extensions donation and introduced Jessica Estrada, representing the Living Streets Alliance, who also supports the project. She said this project is part of the Safe Routes to School Program that will add a crosswalk with curb extensions to help make the crossing of students to and from school safer. A mural will be placed on the extended curbs making the crosswalk brighter, bringing more attention to it. The mural designs were derived from an art activity that students at Pueblo Gardens PreK-8 Elementary participated in during summer school. The theme of the mural is Nature and Animals and will include three elements. Air, Earth, and Water. The location of the artwork will be on the inside of the new curb extensions that are being added at the T intersection at Silvosa St. and Plumer Ave. The artist for the project is Porter McDonald and the project is funded through a grant. Community collaborations include Living Streets Alliance, Department of Transportation, Pueblo Gardens PreK-8 Elementary School, and Pueblo Gardens Neighborhood Association. The installation is planned for a Community Block Party on September 30. Discussion was held.

Committee chair Alex Jimenez asked if the curb was going to be raised and painted. Jessica Estrada (LSA) said no, the curb would be

extended outwards and flex posts would be added, and the paint would be on the asphalt. Committee member Adriane Ackerman asked about the maintenance of the mural painting. Jessica said at the moment there are no plans to repaint it once it wears out. Committee member James "Jim" Glock asked how long the process was, from beginning to now, to get this project in motion. Jessica said it took a few months.

Motion to approve the donation was made by Anne Lopez and seconded by James "Jim" Glock. The motion passed with a roll call vote of 11-0.

7. Donation Review Process Update

After receiving feedback from PACDC members, artists/applicants, and City partners, Abby Christensen, Public Art Collections Manager, provided an update and shared a flow chart draft on the steps/process for reviewing and voting on donation applications. Once the flow chart is finalized, staff will share it with committee members. Staff at the Arts Foundation have proposed having two meetings during the process, to ensure members have a full understanding of the project, giving them more time to review the donation application. Abby created a PACDC Review Packet document that would be shared with the members that could be utilized during the review process. Discussion was held. No action was taken.

The mural donation was submitted by Rhonda Bodfield, representing the Palo Verde Park Neighborhood Association. The artist is Angela Pittenger. Three letters of support were submitted by community stakeholder groups, Palo Verde Park Neighborhood Association, an email from the principal at Kellond Elementary, an email from the Fountain of Life Lutheran Church, and Ward 2. Discussion was held. No action was taken.


9. Outreach to Regional Artists
