CSCC recommends prioritizing the following segments (not listed in priority order), with consideration given to the Move Tucson prioritization

- Glenn St - Oracle to Cherry
- Roger Rd - Oracle to 1st Ave
- Tucson Blvd - 6th to 22nd St and Prince to Ft. Lowell.

Finally, in the event that RTA Next is not successful, the Drexel Rd segments should rise in priority and be added to the list in the event of additional funding.
