## 2. Approval of Minutes: October 18, 2023

# 4. Check on Commissioner Availability for December Meeting and Meeting Format Discussion.

Chairperson Coble began by announcing the next meeting date of 12/20/2023 and inquired about availability due to the holidays. He then touched base on the Public Notice Statement for meetings going forward; Virtually, in person or hybrid to which the decision was to keep meetings virtual, for easier accessibility to all. Commissioner Jordan briefly brought up the possibility of meeting in person once, for a gathering or meeting. It was agreed that it could be done but it must be posted to the public and will be added to future agenda for discussion. It was moved by Commissioner Coble, duly seconded, and carried by a roll call vote of 5 to 0.

# 6. Discussion About the Department of Housing and Community Development's Efforts to Support Affordable and Available Housing for People with Disabilities.

Chairperson Coble opened the discussion by introducing Ann Chanecka from HCD and noted it had been over a year since a meeting had taken place with Housing and Community development. Ann Chaneka began by stating her interest in giving an overview of work from the past year and hearing the prospective of CODI. She started by listing a few projects such as the complete renovation of two single family homes fully accessible, homeownership, the renovation of the Tucson house

with a grant from choice neighborhoods along with the hope of doubling the amount of new affordable housing with ADA standards. Follow up questions were asked by Chairperson Coble, Commissioner Jordan, Bogan and Kroeger regarding the Tucson House modifications, number of units, building plans and new housing projects. Ann Chanecka fielded the questions briefly stating the plans for the Bum Steer, No Tell Motel and the Amazon Motel along with a brief discussion on the ordinance regarding source of income from Rebecca Hill and Ann Chanecka.

# 5. Review and Possible Approval of CODI Report to Mayor and Council on Sun Van.

Brief discussion ensued with Comments from Commissioners and Chairperson Coble in regard to current riders choice, 24 hour services provided in Maricopa County, and accommodation difficulties currently presented.
