#### 1. Call to Order/Roll Call- 3:06 PM

### 2. Approval of the October 4, 2023, IAPC Meeting Minutes

#### 3. Staff Update

Deputy Director of Business Service, Vivian Newsheller, provided an update to the commission. Stated the City's Annual Comprehensive Financial Report is currently being compiled and that the initial department outreach related to the fiscal year 2025 budget is taking place.
