Ms. Miller announced the project is completely funded. Ms. Laraway expressed her excitement at being a part of the project. Committee Vice chair Mel Dominguez congratulated the project team. Committee member Valerie Sanchez expressed her gratitude for the leadership, community minded perspective, and civic engagement provided towards the inclusion and the holistic way of looking at community, art, and culture. Discussion was held.
