In open session, based on the testimony presented and the exhibits admitted into evidence, a motion by Chairperson Fimbres, duly seconded, to deny the appeal demotion for Keith Cubberly, and affirm the disciplinary action. The Commission found that the Appellant knew, or should have known, that his conduct could lead to disciplinary action. The appeal of Keith Cubberly was denied, and disciplinary action imposed upon him be affirmed for the reason that there was just cause for the discipline imposed. The vote was 3-0.

The Chairperson directed the attorney for the Commission to work with the Chairperson to finalize the Commission's written decision.
