Jonathan Schlecht Appeal of Termination Hearing Environmental and General Services Department October 3, & 4, 2023

October 3, 2023 – Day One

A quorum of the Civil Service Commission (CSC) of the City of Tucson met at 9:00 AM on Tuesday, October 3, 2023, at City Hall, 255 W. Alameda in Tucson, Arizona, for the Appeal of Termination filed by Jonathan Schlecht from the City of Tucson's Environmental and General Services Department (EGSD). The hearing was made accessible remotely through technological means as permitted under Arizona law as well as in person.

In open session, based on the testimony presented and the exhibits admitted into evidence, a motion by Commissioner Mathieu, duly seconded, to deny the appeal of Jonathan Schlecht and affirm disciplinary action. The Commission found that the Appellant knew or should have known that his conduct could lead to disciplinary action. The appeal of Jonathan Schlecht was denied, and disciplinary action imposed upon him be affirmed for the reason that there was just cause for the discipline imposed. The vote was 3-0.

The Hearing adjourned at 4:20 PM.
