3.	Welcome & Chairperson's Report Committee chair Jim welcomed the PACD members. No official Chairperson's Report. Chair noted that he'd been approached by advocates of the Free Wall as an individual in December. Jim stated that he will not bring the Free Wall item forward as a PACD agenda item. City staff members on the issue. He also noted he is current president of Warehouse Arts Management Organization (WAMO) and that there may be times in the future that he will have to recuse himself due to arts-related WAMO projects.

4. Public Art Director's Report

Director of Public Art, Wylwyn Reyes, emailed the PDF report to PACD members prior to the meeting as requested. He announced that Sadie Shaw, the new Foundation Community Design Manager, will assume the role of PACD meeting administrator and moderator in March. She will also assist in helping to fill PACD vacancies. He thanked AFTSA's Abby Christensen for her administration support.

There are 42 Active Art Projects with the majority in *Call to Artist* phase. There are currently 19 planned projects in 2024. The last page of the report shows projects by ward/district and funding source.

Jim Glock asked clarification about the definition of "Private Sector" projects; Wylwyn explained that these are funded by donation, not via City funds.

Discussion and vote on the previously introduced project "Save Our Saguaros" mural donation. *Guests: Vianey Avila, Desert Museum, Wesley Fawcett Creigh, Artist.* Abby shared the donation PowerPoint that recapped project status: sample artwork, community support letters, Ward 1 review and support, Parks & Recreation review. She added that City of Tucson Risk Management had recently completed a review.

Artist Creigh explained that she was approached by the Desert Museum to create this mural donation that will be painted by the community. Desert Museum's Avila explained the mural showcases desert biodiversity, celebrates volunteers who work to save saguaros, and brings awareness to dangerous invasive species in our unique environment. It will incorporate three languages. March 9 is slated for the big mural reveal and volunteer appreciation; with drop-in community painting Feb. 23 – March 4.

PACD member Corinne Cooper added that as a Museum



volunteer who pulls buffelgrass, she is thrilled about this mural. Lara Somers asked questions about the A Mountain mural site and potential vandalism. The Museum has contingency maintenance funds allocated; City Parks & Recreation staff reported arts projects/murals have a history of respect and lack of damage by the community. Adriane Ackerman expressed appreciation for including translations, particularly the O'odham language, in this project.

Motion made by Corinne Cooper; second by E. Liane Hernandez. The motion passed unanimously via roll call vote.

7. Public Art Donation Review and Vote

Discussion and vote on the previously introduced project "Arrival of the Railroad in Tucson" a proposed 1000 sq ft mural for the Southern Arizona Transportation Museum, Toole and Congress. Guests: Ken Karrels, Southern Arizona Transportation Museum; Bill Singleton, Artist; Gene Caywood, Chair of Old Pueblo Trolley and member of Museum's technical team; William Kalt, III, Railroad Historian and Author of "Tucson Was a Railroad Town." AFTSA's Abby C. shared the screen with a slide recapping the project with information about the application, maintenance protocol, images of proposed art, and letters of support from Rio Nuevo, Tucson Chinese Cultural Center, and Tucson Downtown Partnership. The City Department response review is complete.

Guest Ken Karrels provided history of the project starting from concept in Jan. 2021, with the efforts of the initial core technical advisory team and the inclusive engagement of key stakeholders, nonprofits, arts organizations, tribal representatives, and area businesses. Funding was received from Ward 5, Pima County Attractions and Tourism, Union Pacific Railroad, Southwestern Foundation for Education and Historical Preservation.

The intent of the mural is to provide education and entertainment for students, residents, and visitors about the railroad, a major force in shaping Tucson. Bill Kalt provided background and context about each of the three panels. Artist Bill Singleton explained the intent to seek out diverse and inclusive input about mural depictions and context.

PACD member Lara S. asked about representation in panel 3 of a Black porter. Discussion followed about ensuring mural viewers understand the history of the Pullman Porters, their unionization, and their role in the Civil Rights movement.

Maureen Lueck made the motion to approve the mural design and amended that it be accompanied by information that provides historical context and cultural contributions of the multi



ethnic diversity of Tucson. Motion seconded by Lara Sommers. Approved unanimously via roll call vote.

8. Public Art Donation Review and Vote

Discussion and vote on the previously introduced project "Dr. V Statue." *Guest: Dave Membrila, Project organizer.* AFTA's Abby C. provided a PowerPoint slide overview of the project including the information packet, maintenance protocol, images of the proposed artwork, and noted support letters from Davis Elementary, Tucson Parks and Recreation, and Barrio Anita. There is ongoing review by Tucson Department of Transportation and Mobility, Risk Management, Structural Engineering Review.

Dave Membrila provided an enthusiastic bio of Dr. V and his role in elevating the importance of education. His visionary work connected culture, education, community, music, and youth. He pioneered and established the nation's first Los Changuitos Feos and Tucson's International Mariachi Conference here in Tucson and has created opportunities for many students, educators, and artists. The proposed statue would be placed at northwest corner of St. Mary's and Main in the right of way.

Motion by E. Liane Hernandez, with a second by Kenna Smith. Approved unanimously via roll call vote.
