2. Approval of Minutes/Legal Action Report – February 7, 2024 Action

Commission Martin requested that staff correct the spelling of Chair Casadei and made a motion to approve the minutes with this correction. The motion was duly

seconded by Commissioner Makansi. The motion carried by a voice vote of 8-0 (Commissioners Huaraque, Kinney, Casadei, and Young absent), to approve the February 7, 2024 Minutes.

3. Major Streets and Routes Plan Amendment Public Hearing

John Beall, Planning and Development Services gave a presentation.

Discussion held.

No members of the public spoke.

A motion to close the public hearing was made by Commissioner Martin and seconded by Vice-Chair Ortiz y Pino. The motion carried by a voice vote of 8-0 (Commissioners Huaraque, Kinney, Casadei, and Young absent).

Commissioner Martin moved that the Planning Commission forward the update of the *Major Streets and Routes Plan* to Mayor and Council to eliminate the Future Right-of-Way Segment of W. Goret Road that extends through the Prince 10 PAD between the Santa Cruz River and Interstate-10. The motion was duly seconded by Commissioner Lampo. The motion carried by a voice vote of 8-0 (Commissioners Huaraque, Kinney, Casadei, and Young absent).

At this point Chair Wellott recused herself and left for the remainder of the meeting. A quorum was still present, and Vice-Chair Ortiz y Pino took over the duties of Chair.

4. Rincon Southeast Subregional Plan Update Public Hearing

Samuel Paz, Planning and Development Services gave a presentation.

Keri Silvyn of Lazarus and Silvyn, Brian Underwood of The Planning Center, and John Oliver of Psomas, representing the applicant, the Arizona State Land Department, presented on and spoke about the proposed plan update.

The motion was duly seconded by Commissioner Makansi. The motion carried by a voice vote of 7-0 (Chair Wellott, and Commissioners Huaraque, Kinney, Casadei, and Young absent).

Linda Morales of the Planning Center, representing the applicant, Mr. Car Wash, gave a presentation.
