

implementation of the Public Art Plan. However, the city has never received such a document and asked the Arts Foundation for the document. However, the Arts Foundation did not provide one. He asked the PACDC members if they will make a plan. He said the Free Wall endorsement was a good start to this plan and asked why they have not made such a plan. Mr. Lawrence also indicated the committee has more power than mere oversight, according to Directive 7, to shape the direction of public art in the city.

Chairman Glock opened up the floor to comments from the PACDC Members.

Comment by Nancy Fung about an interest in more guidance on the Public Art Plan at the next meeting.

Comment by Kenna Smith asking staff to ensure that PACDC members have a copy of the Administrative Directives.

8. Free Wall Letter of Support & Timeline

Chairman Glock introduced the item, Free Wall Letter of Support and timeline over the last three years. He mentioned the last discussion on this item was encouragement by himself when he was interim Chair to ask PACDC members to reach out to their appointed offices to promote the concept of the Free Wall. He opened the floor for discussion.

Adriane Ackerman asked if any PACDC members spoke to their appointed representative and what their response was. She appreciated the timeline and the topic on the agenda and was curious if there was any response to the letter specifically. Adriana Gallego of the Arts Foundation said they followed protocol and submitted the letter to the Boards and Commissions Office on behalf of PACDC to forward to the Mayor and Council as instructed by the former Chair and PACDC members.

Robert Clark mentioned that he submitted the letter to Ward 5 Council Member twice and received no response.

Corinne Cooper said she wasn't on the committee when it first came up, but it came up again at her first meeting. She was contacted by Ward 3 Council Member Dahl and had a conversation around the issue of monitoring the Free Wall if any racist, sexist, anti-Muslim or antisemitic art was put on the free wall. They agreed that they have concerns about that issue.


Lara Somers noted that she contacted the City Manager's assistant and looking at the Free Walls that have been enacted before mentioned that they were on private walls not city walls. She suggested that they look for a private wall rather than a city wall for this concept. Lara Somers asked if the PACDC Members know of any free wall that exists on government property.

E. Liane Hernandez asked Chairman Glock to clarify if he knows of a Free Wall in other states that are on government property. Chairman Glock responded that the instances that he knows of are linked in the Free Wall letter (Austin and Portland) but he was not sure if they were on public or private property.

Lara Somers responded that those may be the cities where a free wall took place on private property. She said that if there was an example of a free wall happening on public property it may be a more useful example.

Adriane Ackerman wondered if there was a tax abatement incentive that could be offered to private property owners who may be interested in exploring this idea. She mentioned that she had not reached out to the Mayor, but was interested in doing so and that perhaps this idea could be added to the Public Art Plan. She was interested in pursuing the idea further.

E. Liane Hernandez asked Adriane Ackerman why she specifically liked the idea of a free wall.





Adriane Ackerman responded that it democratizes public art and gives artists fewer barriers to making art and it also gives artists a place where they can legally express themselves. Artists won't be penalized for covering other people's art. It would also be an interesting social experiment, though she understands the valid concerns expressed, depending on how it is approached there is a way to mitigate harm.

Robert Clark mentioned that he has concerns over a phrase in the materials provided that reads "In the event of anything objectionable, the City be notified and it be removed within 48 hours." He thought that was a long time for what might be unacceptable.

Maureen Lueck asked if the Free Wall concept could be put on the Artist Roster, for an artist to oversee the free wall.

Lara Somers thought that putting the Free Wall concept on the Roster to see if there was a private business that may want to use one of their walls for the purpose of this concept instead of relying on the City.

Adriane Gallego, Arts Foundation Executive Director, asked if this was a call for PACDC to manage and run a Free Wall roster program. Lara Somers responded that she thinks they (they as in the Public Art and Community Design Committee) could possibly oversee that. Melissa Brown-Dominguez mentioned that she spoke to someone in Matt Heinz's office and asked what they thought of the Free Wall. The D2 office said they have no objections if it was in the city but said that it may be difficult if it was in the county. They raised concerns about monitoring and obscenities. She asked PACDC and the Arts Foundation what responsibilities private wall owners would have if they were to take on the Free Wall concept on their property. Mr. Reyes, Arts Foundation Public Art Director, responded that the Arts Foundation manages the City and County's public art program and does not do work for the private sector so the responsibility would fall on the owner of the property and anyone else who wanted to be involved.

Margaret Joplin said that when she was first on the public art committee, when it was TPAC, they had an idea to have a public/private partnership in two alleys South of Congress and West of 6th Ave (the other was North of Congress). During Downtown Saturday nights they charged people \$10 to paint on the wall and polaroids were taken. There was a turnover every week. This same idea can be explored again in a less permanent and more ephemeral way as it was done in the past.

Corinne Cooper expressed her concern that the City or the County would remove Free Wall art if offensive since it raises significant first amendment issues and the City and County attorneys may have an opinion about that.

Nancy Fung stated that she remembers when the letter was being written. She said that it is a free wall for anyone, if there was something offensive it could be covered by people who are working

on it so it would be self-regulated. She noted that the walls the past PACDC members were thinking of were in Santa Rita Park.

E. Liane Hernandez spoke about her experience with a free wall behind Bentley's where she used to work. She is not opposed to the idea but sees that the work of the committee and the free wall are two separate things and that the letter and concept doesn't exactly make sense to incorporate in the Public Art Plan. She likes the examples given in the letter, she has no problem in bringing this up with Lane Santa Cruz of Ward 1 and that it can and will be accomplished again. She mentioned that she feels like the issue of a free wall has become adversarial and unnecessarily so in how it has been pushed forward.

Chairman Glock thanked Committee Member Hernandez and mentioned the Cushing Street Skate Park and perhaps it could be explored at this site.

Adriane Ackerman thanked Committee Member Hernandez and mentioned that she agreed a skate park would be a great spot for this concept. She is interested to see how the free wall could fit in the overall work of the PACDC other work. She offered to do more research on the free wall concept and bring it to the committee. Janet Fischer agreed with Committee Member Ackerman and Hernandez. She mentioned that things were politically charged and wonders if that is why things have become more complicated but that further research will help.

Chairman Glock stated that art has a role in promoting civil discourse and perhaps this is a vehicle that we can continue to explore as far as furthering art in the community.

Adriane Ackerman thanked the Arts Foundation staff for putting together the supplemental materials.

Chairman Glock thanked the Arts Foundation staff as well.

9. Deaccession Subcommittee for Living Lenses

Abby Christensen gave a presentation on the damaged artwork "Living Lenses" by Louise Bertelson and Po Shu Wang and requested 1-2 members of the PACDC to join the Deaccession Subcommittee. Jim Glock and E. Liane Hernandez offered to serve on the Deaccession Subcommittee.

Committee Member Hernandez asked if the purpose of the subcommittee was to deaccession or repair the artwork.

Abby Christensen clarified that the recommendation to deaccession or repair the artwork will be assessed and established by the subcommittee.
