

8. Land Acknowledgement Statement for TPCHC (Discussion/Action) (Commissioner Lozano)

Report was given by Commissioner Lozano. Discussion was held. Action was taken.

It was moved by Commissioner Lozano, duly seconded by Commissioner Riojas, and carried by a roll call vote of 15 to 0 (Commissioners Ireland, Grede, McDonald, and Marks

absent) that the Tucson-Pima County Historical Commission [TPCHC] adopt an Indigenous Land Acknowledgment Statement. The statement was adopted by the TPCHC Transportation Subcommittee in early 2024 and is essentially the same as the statement adopted by the Pima County Board of Supervisors in 2022. The statement was drafted by Supervisor Adelita Grijalva and Pascua Yaqui and Tohono O'odham representatives. Adoption of this particular land acknowledgment does not preclude TPCHC from using an expanded statement at TPCHC public events, for example, the expanded statement crafted with assistance of TPCHC Commissioner the late Joe Joaquin, or a statement that might include the Hohokam or Apache, or a Labor Acknowledgment, etc.

The statement to be adopted by the TPCHC is:

"On behalf of [the residents of the City of] Tucson, [City of South Tucson], and Pima County, we honor the tribal nations who have served as caretakers of this land from time immemorial, and respectfully acknowledge the ancestral homelands of the Tohono O'odham Nation, and the multi-millennial presence of the Pascua Yaqui tribe within Pima County. Consistent with the TPCHC's commitment to diversity and inclusion, we strive toward building equal-partner relationships with Arizona's tribal nations."
