#### 4. <u>Chairperson's Summary of Current Events</u>

Chair Guzman acknowledged the recent mass shootings in Buffalo, New York and Uvalde, Texas and advised all members to be mindful of this approach taken regard these tragic events, even in regard to how police are operating in our schools.

Commissioner Smith asked if the Mayor's Office had made any mention regarding the tragedy in Buffalo, or the shooters manifesto? Chair Guzman stated that he had on only seen the Mayor's comment on policy points regarding illegal guns. He suggested to those Commissioners not currently on the Mayor's distribution list, t get on, and receive updates from the Mayor.

#### 6. <u>Commissioner's Report and Discussion</u>

#### a. Rosa Parks and Ray Davies Funds – Commissioner Molina

Chair Guzman advised the Commission that he would like a Presentation of Certificated from Mayor and Council to recipients of the Ray Davies/Rosa Parks Scholarships in August. Will confirm at next meeting.

# 9. Immigrant Welcoming City / Refugee Advocacy

Chair Guzman advised the of the recent Supreme Court Ruling regarding Border Agents being able to enter a person's home without a warrant, within 100-mile radius of the border. He sited Eggbert v Bull, Case No. 21-147. He stated that these need to be in the forefront for the Commission as this is going to require advocacy for all voices to be heard.
