Jennifer Gutowski, Member of SAVAHCS provided a report on behalf of SAVAHCS.

Jennifer Gutowski mentioned that there was a challenge with their Beneficiary Travel and there is a little bit of backlog, they have hired a national claims processing team. If any asks about it, they are working on it and are trying to get a daily productivity tracker. Jennifer also mentioned that SAVAHCS has a lot of different classes and activities for mindful awareness and moving the body, nutrition, spirit, and soul. In the report provided, there are a lot of classes and resources available, and everyone would love to see Veterans participate.

b. Arizona Veterans' Memorial Cemetery

Committee Member Hollis reported that Paul Marsh who was one of the big leading lights and founding the cemetery, passed away a few weeks ago and there will be a Celebration of Life for him. Committee Member Hollis also mentioned that the Veteran Cemetery in Marana will be having a Missing in America project on October 5, 2024 at 10:00 a.m.

f. Sarah Horvath – Kino Memorial Park

Sarah Horvath is the new Director of the park and gave the committee a brief update on what has been happening at the Kino Sports Complex and the Gold Star Mother Memorial regarding vandalism. 18 of the Memorial Medallions were stolen, and have caused about \$20,000 - \$25,000 in damages so far. The Four Chaplains Plaque was also taken. Sarah and her workers have been working with the Tucson Police Department to try to avoid the vandalism happening.

7. Memorial for Vietnam Veteran Memorial Park – Update/Discussion

Committee Member Byron mentioned that Sarah Horvath's update was for Memorial Park. The granite is purchased, and they need to raise about \$7,500. They ask that everyone spread the word to help donate for the engraving.
