He further stated that he was asked to create resolution 23820 policy as well as the associated Mayor and Council communication and his presumption was that this responsibility would fall to the local boards office in the future given that it deals with PSPRS but that was purely speculation on his part so he sent the information for awareness in the event that they do. He further stated that if not, at least you are aware of the policy and can communicate it to your contacts at the main office in Phoenix.

Attorney Steve Bosse stated that the funding policy and funding issues responsibility lies with the City of Tucson who is responsible for funding and not the pension local boards.
