**3. Call to the Audience**

Chair Smith briefly mentioned Iris Berry possibly joining the Advisory Board, while her application is reviewed as discussed at the previous meeting.

**4. Chairperson's Summary of Current Events**

Chair Smith opened discussion by noting he has reached out to Ms. Rebecca Hill from the OEOP department and is waiting on a response to see about her possibly attending a meeting.

## **5. Commissioners' Summary of Current Events**

Commissioner Webb-Vignery mentioned Pima County Interfaith has received both from the Sheriffs Office and Tucson Police Department a favorable "ok" for the Parish ID, which is for the undocumented and to have all church members carry this. Commissioner Howard ensued in discussion mentioning he has been volunteering with a local nonprofit called Arizona Center for Empowerment (ACE) which mobilizes under resourced people around social justice issues in Tucson and around Arizona. He continued by noting ACE has recently launched a campaign called Water Guardian and the goal is to preserve and protect our water supply. He discussed the background to this campaign stating it is about issues between the 1950s and 1970s where the City of Tucson knowingly served contaminated water to around 31,000 residents on the South Side of Tucson. Commissioner Howard noted there will be another campaign rally at Mission Manor Park January 11<sup>th</sup> from 10am to 12pm.

## **6. Metropolitan Education Commission (MEC) – Rocque Perez**

Commissioner June Webb-Vignery opened item speaking on the background of the Metropolitan Education Commission, she noted in 1990 the City of Tucson and Pima County came with a resolution bringing together the MEC which was set up to be an advocacy group for education k through 20. She continued by noting she was the first executive Director for 27 years and the impact the Commission has with the Youth. Guest Speaker Rocque Perez, who is the current Executive Director, ensued in discussion and presented a slide show which included things such as Commission functions, 30th Teen Town Hall and FAFSA. Chairperson Smith, Commissioners Webb-Vignery and guest Berry had follow up questions regarding visiting State legislators, STEM and Trade/apprenticeships to which Mr. Perez fielded the questions and answered thoroughly.

## **7. Update from HRC Representative to LGBTQ**

Commissioner Webb-Vignery stated at the pervious meeting there were several people interested in becoming LGBTQ Commissioners.
