CALL TO ORDER

• Meeting called to order at 3:33 p.m. by D.Davis; verbal roll call – 5 members present, quorum present

2. Minutes and LAR for Approval

• Approve Nov 20, 2024 minutes and Legal Action Report; motion to approve by K.Schug, second by J.Moscato; no discussion; motion passed: verbal aye/approved=5, no=0, abstain=0

3. Discussion

- A. Tree Inventory Update: by N.Gillett: Final delivery soon; working on QC; about 79K trees w/ 20K vacant spots; full report will include i-Tree analysis; data will be uploaded into MapTucson; work order will be integrated into GIS layer; will get better snap shot of who's doing what; age and size distribution will also be included. No action.
- B. Soil Heath Update: unable to contact Kieran Sidkar; no response from UA and soil monitoring will follow-up.
- C. LAC Vice Chair: discussion of Vice-Chair resignation; potential consideration: J.Moscato or T.Dekoker; no formality on Vice-Chair term, but leads into Chair; Teresa Dekoker willing to be Vice-Chair. Motion by J.Moscato to nominate Teresa Dekoker, second by R.Field; no further discussion. Nomination passed: 7=aye; 0=nay, 0=abstain.
- D. LAC Ad Hoc Committee Updates
 - Plant List. Jenni logged into Dec meeting; no one else logged on; also had meeting 12/3/2024
 (R.Field; E.Dhruv; I.Ogata); will try to finalize filling in plants and criteria by Feb. 2025 to then
 send to larger LAC for review. R.Field=groundcover/vines; I.Ogata=trees & cacti/succulents;
 J.Moscato=shrubs; E.Dhruv=grasses/assist with shrubs; pairing down ADWR list and localizing to
 region.
- E. City Updates: Nicole: finalizing busstop RFP (Wheat Design) and will have contractor selection; ongoing LID code update on hold; plant list could be included into LID code; 2025 planning mid-point of Tucson Million tree sometime in fall partner with S2S looking for great tagline; Grow Tucson grant launch in Jan. Turf rebate/replacement update: HOAs, apts and commercial properties have applied; a couple facilities are now going through Planning permit process; no applications with readable landscape plans due to submittal by contractors; plans currently being denied due to less than 50%

vegetation coverage. Ribbon cutting downtown for new bike lanes from Alameda to Congress, with some GSI on median.
