

4.	Call to the Audience Members of the public must sign-up to speak at the Call to the Audience: Felix Lawrence commented about freedom of expression in public art, the Free Wall and censorship. He said that Mr. Reyes mentioned that the Free Wall could be located at the Cushing Street Skate Park. He asked that the Chair or the PACDC Members push for the implementation of the Free Wall. Mr. Lawrence said he spoke with Shannon Smith, a proponent of the Cushing Street Skate Park, and mentioned this project. members should make a proposal to the Mayor and Council. He also commented on the Leo Kent donation.

Abel Aguilar commented on his issues with the artist selection process, a need to revise the public art policy. He began researching the muralist movement in Tucson and started to focus on large scale works to apply for these opportunities. He said that the art calls always select the same group of artists, specifically that one artist received \$100,000 in commissions this year. He said he met with Arts Foundation staff who were not helpful and that despite the resources provided to him he still did not understand the process.

Comments were made by PACDC Members Janet Fischer, Adriane Ackerman, Corinne Cooper and Melissa Brown-Dominguez.

Ms. Fischer questioned the validity of Mr. Aguilar's statement and said it warranted a discussion. She asked staff to put the issues he brought up on a future agenda.

Ms. Cooper said this came up on a project panel that she served on. When there is an artist selection committee it is an attempt to give each community the agency to select the artist they want, and that it would be a conflict to dictate which artist they select.

Ms. Brown-Domiguez asked staff to provide them with the data to receive clarification on Mr. Aguilar's statement.

5. Committee Member Activity Report

Chairman Glock invited the PACDC Members to speak on upcoming events that may of interest to the committee. Comments were made by Adriane Ackerman, Melissa Brown-Dominguez and Chairman Glock.

Ms. Ackerman stated that she reached out to the Mayor's Office each month since September and confirmed that it is taking time. She also invited people to attend the Desert Drone fundraiser at 831 E. 17th St on the 20th.

Chairman Glock mentioned that the new fundraiser for WAMO will happen with in the Spring.

Ms. Brown-Dominguez invited those in attendance to view Galeria Mitotera's gallery show.

6. Public Art Director's Report

Mr. Reyes gave an update about upcoming public art opportunities next year and introduced the Arts Foundation's newest staff member, Yuyu Shiratori.

8. Introduction of Leo Kent Donation

Ms. Shaw introduced the proposed donation for the Leo Kent Planter Boxes, which included information from the proposal, the steps completed by the applicant and artist, Carly Quinn, as well as the donation criteria that the PACDC Members used to consider when reviewing and approving this donation.

The Artist and applicant gave a presentation on their proposed donation, location, and background of the project.

Ms. Hernandez asked if the metal planters would adversely impact the plant life within the planters.

Ms. Quinn responded that she has worked with the material before and that the plant life within them was thriving. She also noted that the TEP building downtown utilized metal planters and that the plants within them were thriving.

Chairman Glock commented that at Time Market the metal planters had rusted through. He asked if the palm trees in the applicant presentation were still there.

Ms. Silvyn said that the palm tree that is there is not doing well and that they would be working with the owners of the hotel to see if it can be saved.

Ms. Cooper asked which direction the Bienvenidos tile design would face the hotel and that the plant designs would face the street.
