The Historic Landscapes Subcommittee of the Tucson-Pima County Historical Commission conducted a meeting on Thursday, January 16, 2025, at 10:00 a.m. hybrid via Zoom and at Pima Community College, Downtown Campus, Advanced Manufacturing Building, M369 Conference Room, 1255 N. Queen Avenue, Tucson, AZ 85709

1. Call to Order / Roll Call

2. Approval of Historic Landscapes Subcommittee LAR/Minutes from Meeting of: 12-5-2024

Commissioner Erickson moved approval of the minutes of the meeting of 12-5-2024. The motion was seconded by Commissioner Mulder and passed by a roll call vote of 4-0.

3. Review Cases (Discussion/Action)

a. Catalina Park, 941 N. 4th Ave. - Oleander replacement

Mr. Barrett presented a plan for updating the landscape for Catalina Park, which did not include the restroom renovation, which was considered separately. HLS was able to pull up historic images from COT GIS to recommend a course of action.

Commissioner Erickson moved: Commissioner Mulder seconded:

The oleanders scattered through the turf area should be removed; a perimeter planting of Chinese pistache should be installed along the 4th Avenue side of the park and along other perimeters if funding permits; the two Desert Museum Palo Verde trees next to the restrooms should be removed and replaced with two desert willow trees.

An updated plan should be submitted to HLS for verification, since this was not the plan presented at the meeting. Motion passed 4-0.

a. Pima County (PC) Gateway Zones

Ms. McNamara presented an overview of existing gateway zones and potential for the expansion of current zones or the creation of new zones. She will share the sections of PC code summarizing design review for existing zones. The HLS will study this information and ask Ms. McNamara to return if there are additional questions.
