Jim Barnhart with the Vietnam Veterans of America Chapter 106 is going to dedicate a black granite memorial to the 107 Pima County who lost their lives in action in Vietnam and will be dedicated on March 29<sup>th</sup>, 2025 at 9 a.m. at the Kino Veterans Memorial Park also a free luncheon will be provided to the first 200 Vietnam Veterans at the Desert Diamond Casino

**e. Memorial for Vietnam Veteran Memorial Park**

Commissioner Byron briefed the committee on the memorial for the 107 Pima County residents who were killed in action in Vietnam. The plaques are planned to be installed before March 29, 2025.
