3. Update from Law Enforcement.

Lt. David Frisch reports 2024 bicycle fatalities totaled 7 and no incidents so far in 2025. , NO INCIDENTS SO FAR IN 2025. Department is looking at accident data from 2024 in order to allocate TPD officers to most dangerous intersections and roadways.

Committee member asks again when numbers will be updated on the TPD public website, as it only has data through May 2024. Lt. Frisch reports that he will ask TPD research & analysis staff about this.

Discussions/Questions about enforcing crime on the Loop, e.g., ATV use, and where to report incidents. Lt. Frisch reports that an immediate call to 911 would deploy law enforcement, and less urgent matters can be reported a local station, online at Traffic Watch (http://tucsonaz.gov/trafficwatch), or calling TPD non-emergency phoneline (520-791-4444). He encourages people reporting to include time, location, video or photos. He adds that it is illegal for motor vehicles to drive in washes & riverbeds

# City of Tucson – Lydia Barker-Winkworth.

• New Aviation Bikeway & 22<sup>nd</sup> Street Bridge Connector. Explains that connecting these two major roadways forms a crucial east-west connection. Previously, cyclists needed to travel to Broadway in order to proceed east or west. Construction to begin in 2025. Also, the 22<sup>nd</sup> St Bridge will have an 8 foot, barrier protected pedestrian and cyclist path on each side of the roadway. Ingmar points out that many of the improvement suggestions came from TPBAC, noting that the committee does have an important impact on outcomes.

## Pima County – Mike Hendrix.

- Valencia Road project is moving forward with protected bike lanes.
- Houghton Road Multi-use path on the far southeast side, will provide a safe school route for

children in that area.

- Loop extension on south bank of the Rillito between Dodge Ave and Prince St approved by the flood control district. Commencement date coming soon.
- Dodge Bridge: buffered bike lanes are being installed north of the bridge from Fort Lowell Road to Kleindale Road. These lanes will feed into larger Dodge Bridge project. There will be total repavement effort in this area and sealcoating south of Kleindale which will allow for re-striping.
- Mike requests putting Dodge Bridge updates on next month's agenda. He will share the finished
  plans for the bridge as well as graphics showing the striping and updated traffic signs to be
  implemented.

### > PAG - Hanna Odin.

- PAG anticipates a second round of public engagement regarding the regional active transportation
  plan. They are working closely with jurisdictions on the methodology for selecting priority corridors
  and considering feedback from the survey and interactive map.
