4. Tucson Museum of Art and time capsule opening/discussion of new time capsule (Discussion/Action)

Discussion was held. Marianna Pegno from the Tucson Museum of Art (TMA) and the group discussed opening of time capsule buried at TMA as part of the Tucson 250+ event. TMA will be in charge of the stand-alone time-capsule-opening event on August 20, but TPCHC will work with Ms. Pegno to discuss plans for a new time capsule that TPCHC could help facilitate. No action was taken.

5. Initial planning for 2025 events, budget for 2025 event, coordination with COT, community partners, TPCHC budget for FY26), and constituting planning group(s) (Discussion/Action)

Discussion was held. Ms. Hartmann-Gordon noted that she is rearranging layout for event. Community partners will be out on the street. Main stage will be within the Presidio, and elected officials will be gathered there. Ms. Hartmann-Gordon is going to rough out the program (there will be two stages, getting more performers [Gertie and the T.O. Boyz already booked], opening estimated for 20 minutes). She also noted that nothing is confirmed re sponsorships, and she is going to outsource logistics. Marianna Pegno and Commissioners Kubish and Lamb will work with Ms. Hartmann-Gordon on program-related tasks. Discussed obtaining “declarations” from the City and the Board of Supervisors. No action was taken.
