

Pursuant to A.R.S. § 38-431.02, notice is hereby given to the members of the **Tucson Pima County Bicycle Advisory Committee** (TPCBAC) and to the general public, that the TPCBAC held the following meeting, which was open to the public:

The TPCBAC conducted a public meeting on March 26, 2025 via Microsoft Teams.

Draft Meeting Minutes

1. Roll Call, Call to Order, and Approval of May Minutes.

Voice roll call was taken, with 10 members of the committee in attendance (quorum met, please see the list at the end of this document). Ingmar Riedel-Kruse (Chair) called the meeting to order at 6:00 p.m.

MOTION: A motion to approve the January 2025 minutes was made by Krista, seconded by Daphne, and passed by voice vote, 10 yes, 0 no, 0 members abstaining.

2. Call to the Public.

Matthew Taylor, new member representing Town of Marana introduces himself.

3. Updates from Law Enforcement

Gyndon Bolasky, Pima Co Sheriff Dept, sitting in for Lt Crowson: February 2 bicycle-vehicle collisions, neither with life-threatening injuries. One cyclist crash coming down from Mt Lemmon on Catalina Hwy. Five bikes stolen.

Tony Archibald of TPD Traffic Division, replacing Lt. Frisch: so far in 2025: 16 fatal vehicle accidents, with 0 cyclist fatalities. Motor vehicle accidents down by 9, compared to 2024.

Nicole notes that the city has updated its crash data-base through Feb 2025.

4. Review draft of Annual report

Discussion of TPCBAC need for more members, city is doing outreach, Lydia will send out list of vacancies.

MOTION: A motion to approve the Annual Report was made by Randy, seconded by Daphne, and passed by voice vote, 10 yes, 0 no, 0 members abstaining.

5. Review draft letter to UofA for deterring bike theft.

Committee suggestions included gathering data & asking UofA to provide data; mentioning student who

came to TPCBAC meeting; making specific suggestions for deterring bicycle theft; starting interactive Google doc that committee can use to edit letters.

6. Alternative routes to Sabino Canyon / Tanque Verde Intersection

Daphne Hope describes dangers at the Sabino Canyon & Tanque Verde intersections due to increased traffic volume, aggressive behavior, and larger vehicles. Proposes that committee ask Pima Co to priority updating safety there. Options include: 1) improve the intersection, and 2) seek alternative routes, e.g., overpass. Noted: private property ownership issues, money for improvement exists if related to flood control, improvement can only occur on the north bank due to Tucson Country Club Estate property, expanding loop benefits safety & tourism.

Ingmar suggests Daphne write a draft letter to county for committee to review.

Nicole shares link to map that shows her research on bicycle-involved crashes that occurred on Tanque Verde Rd from 2018 to present:

7. Loop extension project

Covered in #6 discussion above.

8. Aviation bikeway rehabilitation report update.

Daphne asks committee which of the improvements/changes suggested in the GABA 2018 Aviation Bikeway Rehabilitation report have been made.

Lydia: the Wooden Bridge has been repaired/reconstructed, but none of the intersections mentioned in report were improved. Possible funding via Complete Streets is available, Lydia suggests writing a letter or going to Complete Streets Coordinating Council meeting to suggest that intersections be redesigned/ improved for safety.

Also noted: 1) safer roadways/intersections would benefit access to 100-Acre Woods Bike Park adjacent to Aviation Parkway. Unhoused encampments and significant financial losses have project stymied. Lydia will reach out to Parks & Rec for update on plan. 2) Plans to connect 22nd Street Bridge with Aviation Bikeway & addition of shared-use lane are paused due to uncertainty about federal funding.

9. Tucson Velodrome update

Lance Jones gives brief presentation on the progress of the Tucson Velodrome Project. Discusses vision for this facility in Tucson. It is a "public-profit" collaboration, located on Pima Co Fairgrounds. Programs geared toward community will include youth cycling teams, school participation, certification programs, and team-building. A "soft opening" is expected in Sept of 2025. <u>Tucsonvelodrome.com</u>.

10. Update on Dodge Bridge

Mike Hendrix reports that contractor has begun removing Dodge Street surface in preparation for repaving. Project goes from Kleindale Ave, north to near the Jewish Community Center. Leading up to and crossing the Dodge Bridge there will be two 10ft lanes for motor vehicles and a 2ft buffer between

the roadway and the bike lanes on either side. The bike lanes will be 5ft wide leading up to the bridge and will narrow to 4ft on the bridge and painted green. Raised road crossings will be on either side of bridge.

Questions/comments discussed: whether or not there should be left-hand turn markings for cyclists, signs stating "bikes can take up full lane", or placing physical barriers/poles between roadway & bike lanes. Some members expressed opinion that barriers may inhibit more "confident/experienced" cyclists, and that roadway markings and signage should target people of varying skill levels. Additionally, due to the Loop extension at Prince & Dodge, overall congestion will likely reduce.

12. Update on construction south-side Olive Road underpass at Univ of Arizona

Anona Miller reports that construction has begun to improve rideability & to clarify mixed-use lanes. They will match the design to the north side of underpass with asphalt bike lanes in the middle and paver brick walkways on either side for pedestrians.

13. Update on holding in-person TPCBAC meeting

Differing opinions expressed: 1) in-person may not be successful if showing up for online meetings has not been. 2) offering hybrid in-person meetings with option of tuning in on-line, 3) hybrid model may feel exclusive to those online. 3) wait until we have filled empty positions before deciding.

Ingmar suggests a social bike ride gathering for committee members before it gets too hot.

14. Potential effects of new federal administrations on TPCBAC/biking

Daphne had shared that the "*NSC Road to Zero*" is temporarily unavailable with the note: "We regret to inform you that as of Jan 30, 2025, the Road to Zero Coalition has received a Stop Work Order from the National Highway Traffic Safety Administration. We are seeking clarification from NHTSA on the nature of the order, but for now the Coalition's work has been put on hold indefinitely." This and potentially similar developments are likely related to changes in funding priorities and perspectives on transportation of the new federal administration.

Mike Hendrix reports that Pima Co is examining all of their grants, but no info yet.

Lydia reports that most projects are local- or state-funded. And larger projects are on-hold right now. 22nd Street Bridge funded by RAISE is a federal grant; it has not been taken back but is on-hold.

Joey reports that any project that includes DEI, social justice, or "green" projects, i.e., planting trees are under extreme scrutiny:
