3.	Education Subcommittee Guidelines  Mr. Reyes, Director of Public Art, gave an overview of the Education subcommittee guidelines as outlined in the City of Tucson's Administrative Directives for PACDC Education program requirements, 7.01-1 G(2).	Study	Wylwyn	5
	He reviewed the information as it is outlined in the Administrative Directives. To his knowledge, the PACDC has never addressed this aspect of the City of Tucson's Administrative Directives. He noted that Arts Foundation staff were here to support the subcommittee but did not want to take on the role of directing how and what the work of the subcommittee would look like.			
	Ms. Ackerman commented that she was interested in focusing on internal education of the PACDC Members in regard to their role and responsibilities before focusing on external education efforts.			

Ms. Hernandez commented that she wanted information about the

communication strategy of the Arts Foundation, so that the

Mr. Reyes gave an overview of some of the ways the Arts Foundation's Communication staff circulated information, including newsletters, social media, press releases, etc.

Ms. Shaw noted that the time to discuss goals for the subcommittee is in the next agenda item and cautioned the committee to stay on topic with this agenda item.

Ms. Shaw introduced the item and asked the subcommittee members if they had any goals they wanted to explore.

Ms. Ackerman stated that she would like the subcommittee to meet regularly, would like the subcommittee to conduct internal education about the roles and responsibilities of the PACDC and the work surrounding it before creating any literature for external education to the community.

Ms. Hernandez stated that she wants the subcommittee to develop an informational kit with staff to disseminate to the community, understanding that the PACDC Members have already indicated that they want to increase participation from local artists, and community members who may not be applying for these opportunities. She asked for information from the Arts Foundation staff about how they spread the word about opportunities and what individuals and groups are already receiving this information in order to identify gaps in the Arts Foundation outreach strategy.

Ms. Ackerman asked if Mr. Varela had any goals that he wanted to suggest.

Mr. Varela noted that he was in agreement with the goals outlined by Ms. Ackerman and Ms. Hernandez.

Mr. Reyes stated that he would reach out to our communication team about compiling that information but noted that they may not be able to compile it before the next meeting.

Ms. Shaw commented that the third Monday at 4 PM could be the reoccurring time and date for the subcommittee's monthly meetings.

Adriane Ackerman moved to approve the Subcommittee goals to meet regularly, develop an informational kit with staff to disseminate to the community, and support and identify gaps in outreach for public art opportunities.
