#### Pima County Updates:

-Cassie Lundine (Pima County) reported the commission's July 18th recommendation to split \$8.5M: \$5M for "Build More" (now including bridge/transitional housing) and \$3.5M for "Keeping People Housed" to support existing stability programs.

Nicole Fyffe noted this is separate from the \$250M/10-year plan starting next fiscal year, funded through property taxes/other sources, with uses guided by the regional housing strategy now in development. ECONorthwest has completed the housing needs assessment and will next work on the strategy and funding plan.
